## Do you believe that public charter schools or other choice schools should have the flexibility to operate autonomously within the bounds of state law, including through waivers of certain local district or board policies? Why or why not?

**Rebecca Kenderdine:** Most public and private charter schools and other choice schools have mostly had the flexibility to operate autonomously within the bounds of state law. The majority of charter schools operate under their own school board in conjunction with district boards. This collaboration is important so that the district is informed about what happens in charter schools and can inform families and communities that these schools are available to their children. It is important for this type of collaboration exist within the district and community.

**John Gustafson:** As a parent I have personally felt a bifurcation of understanding between the prerogatives of the State and the imperatives of me as a parent and at those times I have certainly wished to have more discretion over educational policies and environmental concerns that affect me directly. I know many people who feel the same and I speak for them as much for anyone else.

**Julie Ott:** All schools should be held to the requirements of state law. District schools and charter schools do have some flexibility and are able to legally waive some policies. However, all publicly funded schools should be open to all students, and transparent and accountable with their governance and finances.

**Jennifer Williamson:** I do believe there are situations in which antiquated rules can hinder a school's ability to try new things and meet the needs of today's students. Charter schools can be a place where new ideas are tested and risks are taken to meet the needs of students in creative ways. My friend is the vice principal of Atlas Preparatory Charter School and they have been able to do things like increase teacher pay, that raises the standard for others schools in a way that benefits students.

## If elected, how do you plan to support both new and existing public-school options—charter, magnet, online, specialty, etc.—in your school district?

**Rebecca Kenderdine:** If elected, to District 11 school board, supporting both new and existing public-school options—charter, magnet, online, speciality, etc. can only be supported based on school data, assessments and student success. Listening to parent/citizen comments is also important in order to assess these different schools. It is also important to be a sounding board for the business community.

**Julie Ott:** District 11 offers several program options and is expanding them, including the opening of a Spanish Dual Language Immersion Program at Rogers Elementary and Spark Online Academy. As a current board member, I have supported funding for staffing and resources for these programs. As described in the Academic Master Plan, additional program build-outs are expected. While district charter schools are part of the district family, they are able to operate fairly autonomously as allowed by state law. Charter School Institute (CSI) charter schools are independent of the District. I support keeping communications open between charter schools and the District to promote the education and well-being of students.

**Jennifer Williamson:** I support the Academic Master Plan that would start new magnet programs. I see this as a way of finding new ways to meet the needs of students and building off of the talents of teachers and the needs of the community. The role of the school board is to align resources and support what is working and the programs that are best reaching the students.
